

CALL FOR APPLICATIONS: 2019 Dickson Emeritus/a Professorship Award(s)

The Award:

Created by a gift endowment from the late Edward A. Dickson, Regent of the University of California from 1913 to 1946, the Dickson Emeritus/a Professorship Award honors outstanding research, scholarly work, teaching, or public service activities by a UCSF emeritus/a professor that have continued since retirement. The highest priority is for support of activities that benefit the campus and for which funding is not available from other sources. The awardee(s) shall be known as the Edward A. Dickson Emeritus/a Professor for the duration of the award.

Funding:

Each UC campus receives funds to support one or more awards each year. Each award is for a maximum of \$10,000 and is made to the Emeritus/a Professor for the upcoming two (2) fiscal years. The award may be used for any purpose in conformity with University of California guidelines. However, funds may not be used for recall salary.

Eligibility:

All emeritus/a faculty in all series, including those on recall, are eligible to apply. Activities that may be recognized by the Award include any area of teaching, research or public service. These activities need not be directly related to the nominee's previous career accomplishments.

Evaluation Criteria

The following criteria are used to evaluate applications: **feasibility, innovation, significance, impact and budget**. The most competitive submissions will be those that support activities that benefit UCSF and for which funding is not available from other sources.

Application Review Process:

Applications will be reviewed by an ad hoc Review Committee appointed by the Vice Provost, Academic Affairs. Review Committee members are not eligible to apply for the Award in the year in which they serve. The Vice Provost will make the final decision based on the Committee's recommendations, after which the applicants will be notified. The award recipient(s) will be announced in April.

Reporting:

Award recipients are required to submit two (2) reports to the Office of the Vice Provost, Academic Affairs. A brief interim report showing the balance of funds is due at the end of the first fiscal year. A final report is required within six months after the end of the funding period and should include a summary of activities and an accounting of funds.

All of the components below must be submitted electronically as a single document (PDF or Word).

2. Project Description (1 to 2 pages)
 - Background; current stage of project; current funding, if any.
 - Feasibility, innovation and potential impact.
 - Figures and tables must be included within the 1 to 2 page project description.
 - Bibliography may follow (no page limit).
3. Budget and budget justification (1 page) that outlines in detail how the funds will be used.
4. NIH-style biosketch (not to exceed 4 pages).
